### **HOW TO ENTER**

These rules govern the **Jazz Ticket Tuesday Giveaway** ("Contest"), which is being conducted by **KZNS** ("Station"). The Contest begins on **November 12, 2024** and ends on **November 12, 2024** ("Contest Dates"). Entrants may enter via on-air entry.

To enter the contest, entrant may enter by listening every Tuesday from 6 am to 6 pm beginning on **November 12, 2024 at 6 am MT** and ending on **November 12, 2024 at 6 pm MT** ("Entry Period") as follows:

Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.

Only one (1) entry per person is permitted. There will be up to a total of **ten** winner(s) selected in the Contest every week.

### **ELIGIBILITY RESTRICTIONS**

The Contest is open to all persons who are legal U.S. residents of the state of **Utah**, eighteen (18) years of age or older. Void where prohibited or restricted by law.

The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees

(i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. These restrictions also apply to immediate household members of contest or prize winners.

To claim a prize, the winner(s) must provide valid government-issued photo identification and provide their complete address, date of birth, phone number, email address and Social Security Number.

Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

## PRIZES

**(Ten)** prizes will be awarded. On **November 12, 2024** each prize consists two tickets to the **Utah Jazz vs San Antonio Spurs on November 26, 2024 at Delta Center**. The Approximate Retail Value ("ARV") of the prize(s) is \$50. Transportation costs are **excluded** in the given price. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). **Tickets** are valid only on the date(s) printed on the **tickets**, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation,

preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station or Contest Administrator or Sponsor, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.

If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

Further,
